#### **Need for training:**

Cyprus has adopted its International Commercial Arbitration Law 101/1987 (Law no. 101/87) which is based on the UNCITRAL Model law (1985) since 1987.

Cyprus is also a member of the New York Convention (United Nations 1959) since 1980.

Through these two legislations, Cyprus entered the arena of International Arbitration.

In addition, the Foreign Courts Judgments (Recognition, Registration and Enforcement) Law of 2000 (Law No 121(1) 2000) provides for the procedure to be followed by a party wishing to have a foreign award recognized and enforced in Cyprus.

The need arises from the frequent use of International Arbitration between local and international companies in Cyprus.

Through the program, trainees will understand the general principles of International Arbitration and its relationship to other dispute resolution methods and will refer to the procedure from the appointment through to the issue of the award. The training will refer to the structure of the award and the recognition and enforcement of the award. The program will specifically analyze and explain the Cyprus International Arbitration law.

## **Objectives:**

- 1. Relate International Arbitration to other forms of dispute resolution.
- 2. Understand the procedure and practice of International Arbitration.
- 3. Understand the legislation affecting International Arbitration in Cyprus. Formulate the history and meaning of International Arbitration.
- 4. Name the criticality and what one should pay attention to in the arbitration agreement, the procedure and the award
- 5. Understand the basic principles of International Arbitration
- 6. To separate the concept of International Arbitration, with special reference to the laws of other countries but also to the UNCITRAL MODEL LAW.
